IMPORTANT: The purpose of this form is to identify potential Former Owners only. It should not be completed by the current owner of an eligible vehicle. This form is only the first step in the claims process for Former Owners. **In order to receive a Former Owner Restitution Payment, you must also submit a valid claim during the first 60 calendar days of the claims period, which we expect to begin in late May.** Failure to take both steps in the required period will disqualify you from the Settlement. Further detail will be provided to you upon final approval of this Settlement.

If more than one person or company owned the vehicle at the time of sale or transfer, please provide information for each such person or company. All fields in each required section must be completed for the form to be accepted and valid.
